# Cannabis industry in Eastern Switzerland

The cannabis industry has been booming since 2016, due to the legalization of CBD products containing less than 1% THC. In addition the production and export of medical cannabis containing over 1% THC is permitted since August 2022. Pilot projects relating to the authorization of recreational cannabis are also underway.

With traditionally strong agricultural, foodstuffs and phytopharmaceutical industries, Eastern Switzerland is the ideal location for companies in the cannabis sector.

## REGULATION

### CBD products

Under Swiss law, CBD products may contain up to 1% THC, whereas most European nations will only permit a maximum of 0.2% THC. CBD products can only be marketed legally if they comply with the legislation of the country where it is placed on the market. Depending on the classification, the corresponding Swiss legislation is applied.

### Medical Cannabis

The production and export of medical cannabis containing over 1% THC is permitted since August 1, 2022. Due to the removal of the prohibition in the Narcotics Act, cannabis for medical purposes is reallocated from the List of prohibited narcotics to the List of substances subject to control measures by swissmedic. ### Recreational Cannabis

Pilot projects are underway relating to the authorization of cannabis for leisure use containing max. 20% THC. Experts predict that regulation/legalization will be achieved within the next few years.
